Let's show the Welsh Assembly Members (these are the people who are just about to make the decision on the level of funding the council receives) how fed up we are with the continual cuts to our services.

The petition asks the Assembly Members to keep the present level of funding for Neath Port Talbot County Borough Council when setting the budget this Autumn. Our council is one of the most deprived councils areas in Wales and following the recent years of cuts finds itself cut back to the bare bones.

Further budget cuts will:-


- devastate local jobs, services and communities.
- put the most vulnerable within the Borough at further risk.
- have a huge impact on the local economy the Council being a major employer.
- mean vital services are at risk of becoming unsustainable with the potential for outsourcing to the private or third sector. This results in the loss of democratic accountability.
- result in more deprivation in our communities, compulsory redundancies and the extinction of our vital services.
- mean disruptive, costly and poor quality service provision.
- mean the possibility of changes to employees terms and conditions.

The Welsh Government needs to spend smarter not spend less, without smart spending our community will see the extinction of vital services. Wiser allocation of finances is essential, for example, to ensure a vibrant integrated Social Care model fit for the 21st Century, Neath Port Talbot County Borough Council require funding to be pass-ported from Health to Local Government.

The Government vision that everybody in Wales should live in well-connected vibrant, viable and sustainable communities with a strong local economy and good quality of life is ESSENTIAL- It is what we all deserve. But in order for this vision to materialize public services must be safeguarded. This will ensure that the residents of Neath Port Talbot County Borough Council have a belief in a better future.

Welsh Government must understand that leaving Neath Port Talbot County Borough Council to pick up the bill for national policies is not an option.

Welsh Government must ensure that Neath Port Talbot County Borough Council receives fair funding.



### Lobbying MPs for FAIR FUNDING in Parliament

Mark Fisher, your Branch Chairman, visited the Houses of Parliament to lobby MPs over Fair Funding for Local Councils on September 4th.

Mark spoke to lots of MPs including Stephen Kinnock (MP for Aberavon), Christina Rees (MP for Neath) and Angela Rayner (Shadow Secretary of State for Education) to discuss the Barnett Formula funding stream from Westminster.

Mark was able to discuss the local difficulties Neath Port Talbot Council have with their continuous budget cuts and the effect it is having on staff, local services and the community particularly with Stephen Kinnock and Christina Rees.

Mark was pleased that both Christina and Stephen supported more funding for local authorities, and agreed to lobby for the change of the funding formula which will assist the Welsh Government with their allocation to local authorities. This made it a very successful and worthwhile visit.

#### Latest negotiations on changes to the ER VR Scheme

Following a series of in-depth discussions at full UNISON Committee Meeting, the Committee have reluctantly agreed to accept the reduced ER/VR Scheme (45 weeks). However this was only on the provision that this scheme stayed at 45 weeks for as long as the Forward Financial Plan stands – we believed this to be 3 years. It was consequently confirmed by the Council Officers that the scheme would be in place until *at least* 31st March 2022.

The revised terms of the scheme will be presented to Members at Personnel Committee on 15<sup>th</sup> October, and, subject to their approval, it will be operational from that date.

The negotiation team endeavours always to get the best deal possible for members.

## Local Question lime

It was an excellent turnout with standing room only from staff on the 21st September for the 'Question Time' of local politicians. The AMs and MPs heard how brutal spending cuts have damaged community services, they were pressed on the way forward. Staff voiced their intension to lobby for an end to austerity and for a fair funding deal for Wales. Labour's Shadow Secretary of State for Wales Christina Rees MP, Stephen Kinnock MP, David Rees AM, Jeremy Miles AM, David Rees AM, Bethan Sayed AM, Mike Hedges AM, Steven Phillips NPT Chief Executive attended with a series of testing questions coming from the audience.



The free event has been organised and run by UNISON Cymru/Wales Black Members at Butetown Community Centre, Cardiff. The event was to remember our brothers and sisters who gave so much in their struggle for freedom. The Chair of UNISON Cymru/Wales Black Members (Kebbah Manneh) welcomed the speakers Roger McKenzie (UNISON Assistant Secretary), Aileen Burmeister (National Co-ordinator, Fair Trade Wales), Stephen Chapman (Anti-Slavery Co-ordinator Welsh Government) and thanked Vaughan Gething (Cabinet Secretary for Health, Well-being, and Sport) for his video message.

The speakers explored modern slavery in the UK and how people are

trafficked into UK from overseas for forced labour in industries such as agriculture, construction, hospitality, manufacturing and car washes. They also highlighted how many women and girls are trafficked for sexual exploitation and domestic slavery and how children are forced into crime including cannabis production, petty theft and begging.

Stephen Chapman explored how communities and organisations can continue to combat the very real threat of slavery that remains in the world and what the people of Wales can do to support this work.

#### Workshop to Raise Awareness of Prevent duty training (WRAP)

'Prevent' is part of the UK's Counter Terrorism Strategy, preventing people From becoming involved in terrorism or supporting terrorism.

rom 1st July 2015, all Local Authorities have been required to prevent vulnerable adults and young people from being drawn into terrorism.

Staff must know how to identify people who are at risk of radicalisation and what to do when they are identified.

Home Office-accredited training has been specifically written to address these needs, with specialist workshops designed by HM Government available for all staff to give an introduction to the 'Prevent' strategy and an individual's role in safeguarding vulnerable people. The course includes case studies, local infor-

mation, and the referral pathway.

The WRAP Training course covers:

- an overview of 'Prevent' as part of the Government's counter terrorism strategy, legislation and guidance,
- what makes people vulnerable,
- ★ how to identify the risks,
- \* 'Prevent' as it relates to safeguarding and how and when to reportconcerns.

## NPT Community Chest: £1500 for local clubs

Are you a member of a sports club, or an organization that promotes physical activity, and if so could your club use £1500? Community chest could help you! Community Chest is a Sport Wales initiative and managed locally.

The Neath Port Talbot panel have awarded almost £1.5 million to local clubs since its inception.

Neath Port Talbot council's Physical Activity & Sport Service (PASS) Development Officer Derek Jones said this funding has allowed new clubs to be formed and existing voluntary organizations the opportunity to expand and improve.

The purpose of this Sports Wales initiative is to make a difference to local sport and physical activity opportunities that are additional to what is already in place and would not be possible without a grant; and to increase participation, improve standards of performance and encourage more people to become physically active more often.

Some of the main areas of criteria are: recruitment of volunteers, coach education (qualification and upskilling of coaches), first aid costs, new additional club/team start-up costs, non-personal items of equipment, publicity, community club and school links. The priority areas are black and minority ethnic, disability (inclusion), women and girls, children, young people and families experiencing poverty, and areas of deprivation.

Who can apply? Any group that holds an account (be it a bank, building society or credit union account) in their organization's name. You'll probably be one of the following: sports club or asso-


